Main Stage Performers Rules & Guidelines



August 3 and September 14 2013
Application deadline June 19, 2013

Performers wishing to apply for the *WaterFire Sharon Main Stage* must submit the application along with one (1) high resolution photo of group/act via postage paid mail (7 W. State Street, Suite 301; Sharon, PA 16146) or email to dayna@waterfiresharonpa.org. Include *WaterFire Sharon Main Stage* in the address and/or subject line.

A confirmation of receipt of submission will be sent to all applicants via email. A panel selected by WaterFire Sharon will conduct the selection process. After reviewing submissions, the panel will invite performers to participate. Performers will be notified by July 1, 2013 of status of application.

The *WaterFire Sharon Main Stage* is a large uncovered stage erected in the parking lot behind the Shenango Valley Chamber of Commerce for WaterFire Sharon events. Professional technical support is provided. Please note that drum sets, pianos/keyboards, instrument amps, etc. are NOT provided by WaterFire Sharon.

Sets are 60 minutes with ½ hour transitions between acts. The following times are available:

Saturday, August 3, 2013

Noon – 1:00 p.m.
1:30 – 2:30 p.m.
3:00 – 4:00 p.m.

Saturday, September 14, 2013

Noon – 1:00 p.m.
1:30 – 2:30 p.m.
3:00 – 4:00 p.m.

WaterFire Sharon will pay all groups selected to perform on the *WaterFire Sharon Main Stage* a performance fee of \$300 per one (1) hour set. Performance fees are non-negotiable.

Rules:

1. In order to ensure a diverse range of performers, a complete description of act must accompany entry form.
2. The *WaterFire Sharon Main Stage* panel will determine acceptance and reserves the right to remove any performer that has been misrepresented in the application.
3. To avoid scheduling conflicts, applicants are required to let WaterFire Sharon know if members of this group are associated with other acts applying to the *WaterFire Sharon Main Stage*.
4. Performers agree to allow WaterFire Sharon to use submitted images submitted in the promotion and advertising of WaterFire Sharon events.
5. By signing and remitting the *WaterFire Sharon Main Stage* application form, the performer agrees to abide by all *WaterFire Sharon Main Stage* rules and guidelines. Any violation of the rules will result in removal from the WaterFire Sharon Main Stage performance.
6. Acceptance to the *WaterFire Sharon Main Stage* cannot be reassigned to another performer.
7. All applicants expressly agree to release the WaterFire Sharon, the City of Sharon and their agents from all liability for injury, damage or loss to persons or property.
