## Performance Dot Community Stages Rules & Guidelines



August 3, September 14 and October 12, 2013 Application deadline June 19, 2013

Performers wishing to apply for the *Performance Dot Community Stages* must submit the application via postage paid mail (7 W. State Street, Suite 301; Sharon, PA 16146) or email to <a href="mailto:dayna@waterfiresharonpa.org">dayna@waterfiresharonpa.org</a>. Include *Performance Dot Community Stages* in the address and/or subject line.

The *Performance Dot Community Stages* are a series of four painted performance "dots" with an approximate 12' radius located throughout the city. Designed for street performers, the performance dot stages are color coded – Red, Yellow, Blue and Green.

Performers are given ½ hour timeslots and may perform up to four (4) times during each WaterFire Sharon event – once at each performance dot location. One application can be made for all three WaterFire Sharon events. There is no payment or performance fee made to participants who choose to perform at one or more of the *Performance Dot Community Stages*. Timeslots are filled on a first-come, first-serve basis and WaterFire Sharon reserves the right to schedule the *Performance Dot Community Stages* as they deem most appropriate. Half hour timeslots are available from 10:00 a.m. – 7:00 p.m.

All applicants will be notified by July 1, 2013 of performance times and locations via email provided.

## Rules:

- 1. Performance Dot Community Stage performers will be scheduled in ½ hour timeslots. Set-up and tear-down time is included in this ½ hour timeslot. Performers are responsible for managing performance times.
- 2. *Performance Dot Community Stage* performers will receive NO technical or other assistance from WaterFire Sharon staff or volunteers.
- 3. By signing and remitting the *Performance Dot Community Stages* application form, the performer agrees to abide by all *Performance Dot Community Stage* rules and guidelines. Any violation of the rules will result in removal from the event.
- 4. Acceptance to the *Performance Dot Community Stages* cannot be reassigned to another performer.
- 5. All applicants expressly agree to release the WaterFire Sharon, the City of Sharon and their agents from all liability for injury, damage or loss to persons or property.
